Operating Instructions

Mix A and heat up to 75-80°C. Mix B and heat up to 70-75°C. Add B to A and homogenize for a few minutes. Cool down to room temperature under gentle stirring. Below 30°C add C-E in this order and homogenize for a few minutes. Adjust pH value to 6-6.3 with F.
